073/10 Minutes of Last Meeting

075/10 Update on Issues and Actions from Last Meeting

076/10 Public Participation

i) PC Diana Wilcock: There had been no reported crime in Colton in the last few months. The priority was now illegal off-road behaviour. PC Baldwin had followed 7 bikes off-route on the Torver fells; he was talking with the National Park about how best to tackle this problem.

- iv) Speed Limits: A reply from CCC Cabinet was imminent following concerns expressed by Local Committee; Cllr Wilson had flagged up in particular the lack of limits at Bouth.

081/10 Planning

The following planning application was discussed and a response agreed:

-7/2010/5237 - 1, The Fold, Oxen Park - Subdivision of property into two dwellings and installation of double-glazing. **Resolution:** No objection.

Responses to planning applications were noted as follows:

-7/2010/5196 - Charcoal House, Nibthwaite - erection of garage. *No objection.*

-7/2010/5251 - Oxen Park Farm, Oxen Park - minor material amendments to application 7/2005/5759. *No objection.*

-7/2010/5224 - Bouthrey Bridge reconstruction - Option B (Colton and Blawith Councils' favoured option). *No objection.* Blawith & Subberthwaite Parish Council's response on the higher parapet was also noted.

-7/2010/5232 - Sinder Hill, Finsthwaite - Second bathroom and fire escape route. *No objection.*

-7/2010/5109 - Cedar View, Rusland: New opening in boundary wall to create vehicular access with on-site parking for 2 cars.

The following tree preservation order was noted:

-TPO 344: Cedar View, Rusland: 2 yew trees in garden next to boundary wall

The following certificate of lawful use was noted:

-2, Rose Cottage, Bouth: Use as dwelling house.

The listed building condition survey being conducted for the National Park was noted.

082/10 Highways

- Green Roads Task and Finish Group: A meeting was being arranged in July as explained in Cllr Wilson's report (see 077/10 above)
- Skowbarrow Lane, Beck and road repairs, Rusland: The Clerk had spoken to Mr Crowe. Repair of the Lane was awaiting its adoption by the National Park as a formal right of way. Dredging of the Beck, and the extensive flooding on the road that it caused, was still unresolved. The Council would write to the relevant bodies to try to resolve the issue; the Clerk would seek advice from Tony Hill, LDNPA Ranger.

083/10 Meetings

The following meeting reports were received:

- LDNPA Local Development Framework Hearing, 12th May: Cllr Potts reported: the Planning Inspector had included an Agenda item on the Council's concern about designation of Lakeside as a development site. As a result of Colton's submission, the National Park had agreed to re-word the Core Strategy to define the development area as solely the Lake Cruises terminus, the surrounding public area and the Lakeside Hotel. A letter had been received inviting comment by 12th July on the changes made to the Core Strategy; the Clerk and Cllrs Barr and Potts would review it and circulate a draft response.
- High Furness Local Area Partnership, 12th May: Cllr Dean had sent a report to the Clerk. The

new Chairman was Michael Slinger (Kirby Ireleth) and Vice-chair David Fletcher (Satterthwaite). There had since been a series of email exchanges on protocol between the Chair and County officer - the new Chairman wanted to initiate a process for improving highways services that the County officer said was not within the remit of the LAP. Cllr Dean and other LAP members were concerned about the direction the LAP was taking. There was general concern at the proliferation of groups and the number of meetings to be attended. Cllr Taylor asked whether the LAP and the Neighbourhood Forum could not be combined, since they now represented the same parish groupings. Cllr Barr explained that they had different agendas, but it was thought that in due course their administration might be combined.

- Hydropower Meeting, 15th May: Cllr Taylor reported on a successful meeting. He thanked John Ruskin school for the venue and support and the Clerk for producing the meeting report and webpage. There had been enthusiasm for setting up an informal 'High Furness Hydropower Group'. Cllrs Taylor and Davies had attended Sir Martin Holdgate's talk on renewable energy following his scoping study on renewable energy for 'Cumbria Vision'. Key messages were: we should use less energy and absorb more CO₂; the likely exclusion of wind-farms from the National Parks and AONBs; rapidly evolving technology made recommendations difficult; planning approval for renewable energy systems was hard to obtain; there was a need for more coordination between the Parks and County.

It was agreed that the Green Energy Working Group should meet and prepare proposals on membership and ways forward, bearing in mind Sir Martin Holdgate's report for Cumbria Vision and the new networks that might emerge as a result.

- LDNPA Planning Seminar, 15th June: The Clerk reported the main points: i) parishes should substantiate comments with material information, ii) about 35% of applications were taken to the Development Control Committee due to difference of opinion between Park and parish council, iii) Local Plan policy was not necessarily binding, but was open to interpretation and balanced judgement between local needs, local policy and national policy. iv) house-price-to-income ratio in the Park was around 12/1, but up to 26/1 in some areas; this was of great concern, but housing policy was the domain of the district councils. However, the Park for the first time was looking at the allocation of land for housing in its developing policy. v) compliance officers investigated c. 300 cases per year of which 28% were not a planning matter, 14% already had planning permission and 8% were permitted development. Of the 50% in breach, the large majority were resolved by the owner, granted retrospective permission or deemed not expedient to enforce; only 5% received enforcement notices. vi) There were powers to enforce clean-up of 'untidy land' and also to control signage.
- LDNPA Partnership Management Plan meeting, 17th June: No-one had been available to attend.
- CALC - South Lakeland District Association meeting, 17th June: The report was deferred until the next meeting when Cllr Dean would be present.
- Partnership Budgeting Workshop, 21st June: No-one had been able to attend. The Clerk would ask neighbouring parishes for a report.
